1. ABOUT THIS POLICY

Maruichi Kanko operates (<https://www.maruichi-gp.co.jp/>) This site informs you of our policies regarding the collection, use and disclosure of Personal Information we receive from users of the Site.

At (<https://www.maruichi-gp.co.jp/>) , we recognize that privacy of your personal information is important. Here is information on what types of personal information we receive and collect when you use and visit (<https://www.maruichi-gp.co.jp/>) , and how we safeguard your information. We never sell your personal information to third parties.

We use your Personal Information only for providing and improving the Site. By using the Site, you agree to the collection and use of information in accordance with this policy.

2 Handling of personal information

Respecting the privacy rights of our customers is very important to us.

Pursuant to the Law Related to Privacy Protection and our privacy protection policy, our company strictly handles customer personal information as follows and endeavors to ensure its protection.

Purpose of use of customers' personal information

- (1) As with most other websites, we collect and use the data contained in log files. The information in the log files include your IP (internet protocol) address, your ISP (internet service provider, such as AOL or Shaw Cable), the browser you used to visit our site (such as Internet Explorer or Firefox), the time you visited our site and which pages you visited throughout our site. In addition, we may use third party services such as Google Analytics that collect, monitor and analyze this;
- (2) To send you e-mail notifications about our new or existing products and services, special offers, or to otherwise contact you;
- (3) may provide transportation, lodging and other facilities as well as the Agents making arrangements with customers' names, addresses, telephone numbers and other information within the necessary scope in order to arrange the requested travel;
- (4) To enhance existing features or develop new features, products and services;
- (5) To request a response to questionnaires;
- (6) To provision of special-offer services;
- (7) To allow us to personalize the content and advertising that you and others see based on personal characteristics or preferences;
- (8) Preparation of statistics materials;
- (9) When complying with the laws, regulations or ordinances;
- (10) When disclosure is necessary for the protection of human life, human health or property and when it is difficult to obtain the consent of the person from whom the data was obtained.

3 Cookies

We employ cookie technology to help visitors and customers move faster through our site. When you sign on to our Web site or take advantage of several key features, we may pass cookies to your computer. A cookie is a string of information that is sent by a Web site and stored on your hard drive or temporarily in your computer's memory.

4 Security

The personally identifiable information we collect about you is stored in limited access servers. We will maintain safeguards to protect the security of these servers and your personally identifiable information.

5 Changing our Privacy Policy

Laws and practices change over time. Should we decide to update our privacy policy, we shall publish the changes on our website. If we change the way we process your personal data in any substantial way, we shall notify you in advance, or where required by law, ask your permission before implementing these changes.
